

I Have served on my HOA board for the past 3 years where I am also a member of the Architectural Review Board. I have also served for the past 2 years as the Program Director on the Middle TN Information Systems Security Association board of directors. In addition, I am a member of the program committee for the largest Information Security conference in the world, RSA which is held every year in San Francisco with 40-50,000 attendees. Finally, I am a member of the Williamson County Amateur Radio Emergency Service chapter.

What compelled you to run for this position? *

Seeing firsthand the impact that the board has had over the past few years handling the pandemic is what compelled me to run. Just as all companies were able to watch how their leaders navigated these uncharted waters, true leaders quickly rose to the top while others floundered, and their company's performance directly reflected this. We are all created with a need for in person relationships. And while obtaining post graduate degrees and other specialized adult training can be effective virtually, k-12 instruction should be in person. Remote learning does not work to teach our students the base concepts that they need to thrive. Parents know what is best for their students and I am running to give them a voice on the board.

What do you believe is the most important quality or characteristic for a Williamson County School Board member to possess and exhibit? *

Levelheaded leadership and intentional listening are the most important qualities that I believe a school board member should possess. It's easy to lead when times are good but when challenges occur, it is critical to listen and calmly respond with critical thinking and problem-solving skills.

What are your thoughts on the School Board races being partisan this year due to the new state legislature that passed in late 2020?

Every public official in my opinion should be required to declare and discuss their political leanings as this does impact how they make decisions. We shouldn't make this a pillar of the campaign but I believe in being fully transparent and aligning with a political party can be one indicator of a candidates views on important issues.

What, if any, involvement have you had in local or state politics before running for School Board? *

Back in Texas, I served one term on city council in a small town outside of San Antonio as well as serving on two different city planning and zoning commissions. Since moving to Tennessee, I have been actively attending rallies both in Franklin as well as at the capital in Nashville and have called and emailed county and state officials dating back to 2019 on various important issues.

Have you ever spoken at public comment during a School Board meeting? If yes, please provide details on the topic.

I have attempted to speak at a few of the meetings last year but the meetings were so full that I was not allowed into the auditorium. I have spoken at one county commissioner meeting during the public comment period related to the school board.

If you had to describe a School Board member's role in 1-2 sentences, what would it be? *

The boards role is to direct the mission, vision and strategic plan of the district, to hire and evaluate the superintendent, to review and approve policies as well as the budget. Let's get back to the basics, remove the politics and put kids and teachers first.
